- School Discipline: Detentions, Time Outs, Community Service, etc.
- Short Term Suspension: 1-10 Days in or out of school
- Long Term Suspension: 11-90 Days
- Expulsion:
- Emergency Expulsion: Up to 10 days to investigate, must be a safety issue, and must be changed.

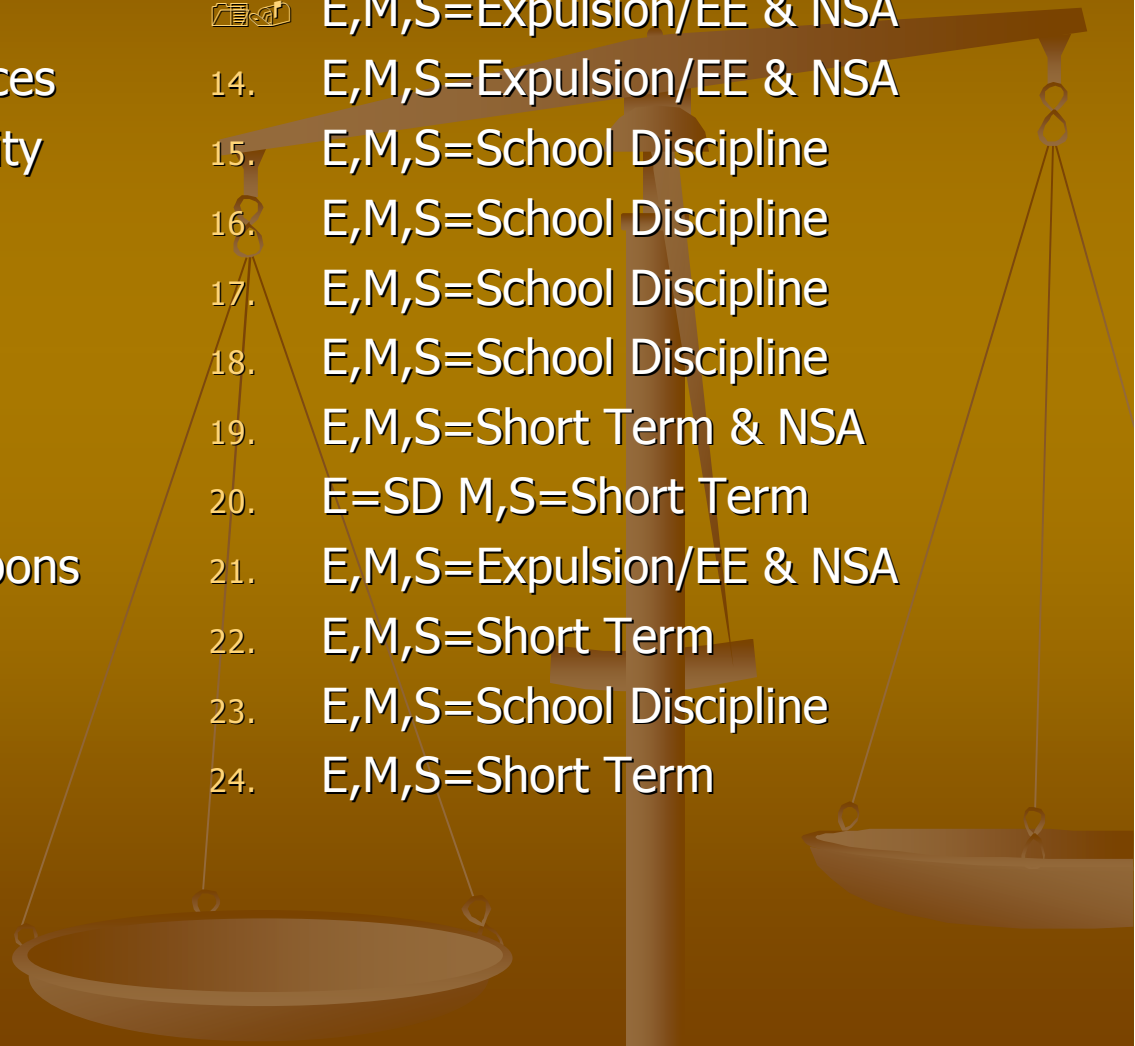



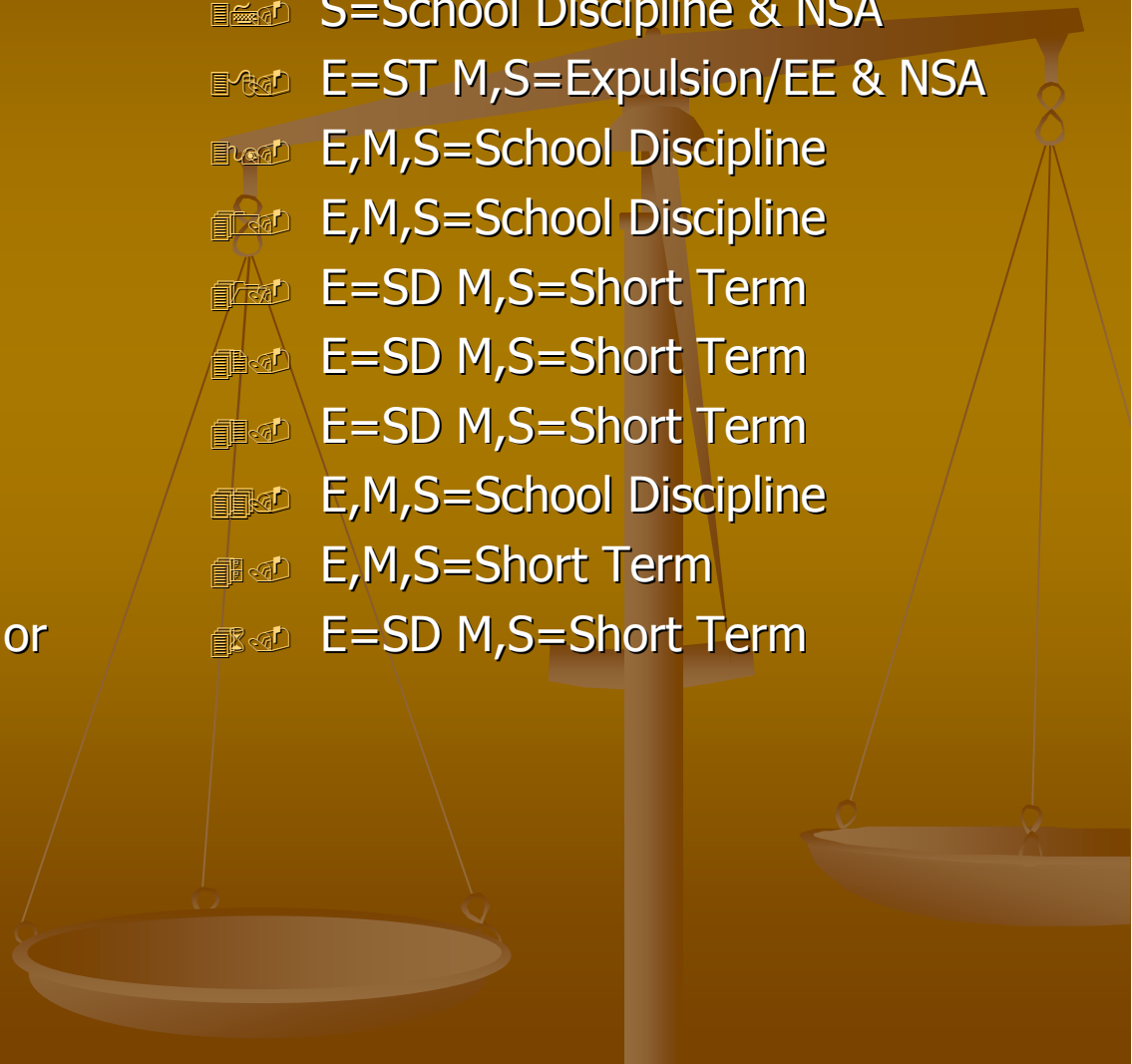
