This Release, Assumption of Risk and Indemnification Agreement (Agreement") is entered into this _____ day of _____, 20____, between the undersigned and any and all and each University High School Senior All-Nighter Committee and each and every individual member of that committee, their officers, directors, agents, representatives, and employees (collectively the "Committee"). In consideration of my participation in the ("Event") and based upon my understanding that my participation at the Event is on condition that I enter into this Agreement. I, for myself, my heirs and assigns, hereby assume any and all risk inherent in this activity which is connected with the Event. I voluntarily participate in the Event and I expressly assume the risk of an accept full responsibility for any and all injuries (including death) and accidents which occur as a result of my participation in activities connected with the Event. I hereby agree to indemnify and hold harmless all of the above named persons for any and all claims, including attorney's fees and costs, which may be brought against any of them by anyone claiming to have been injured as a result of any injury to me which occurred or may occur as a result of my participation in or travel to and from the Event.
